

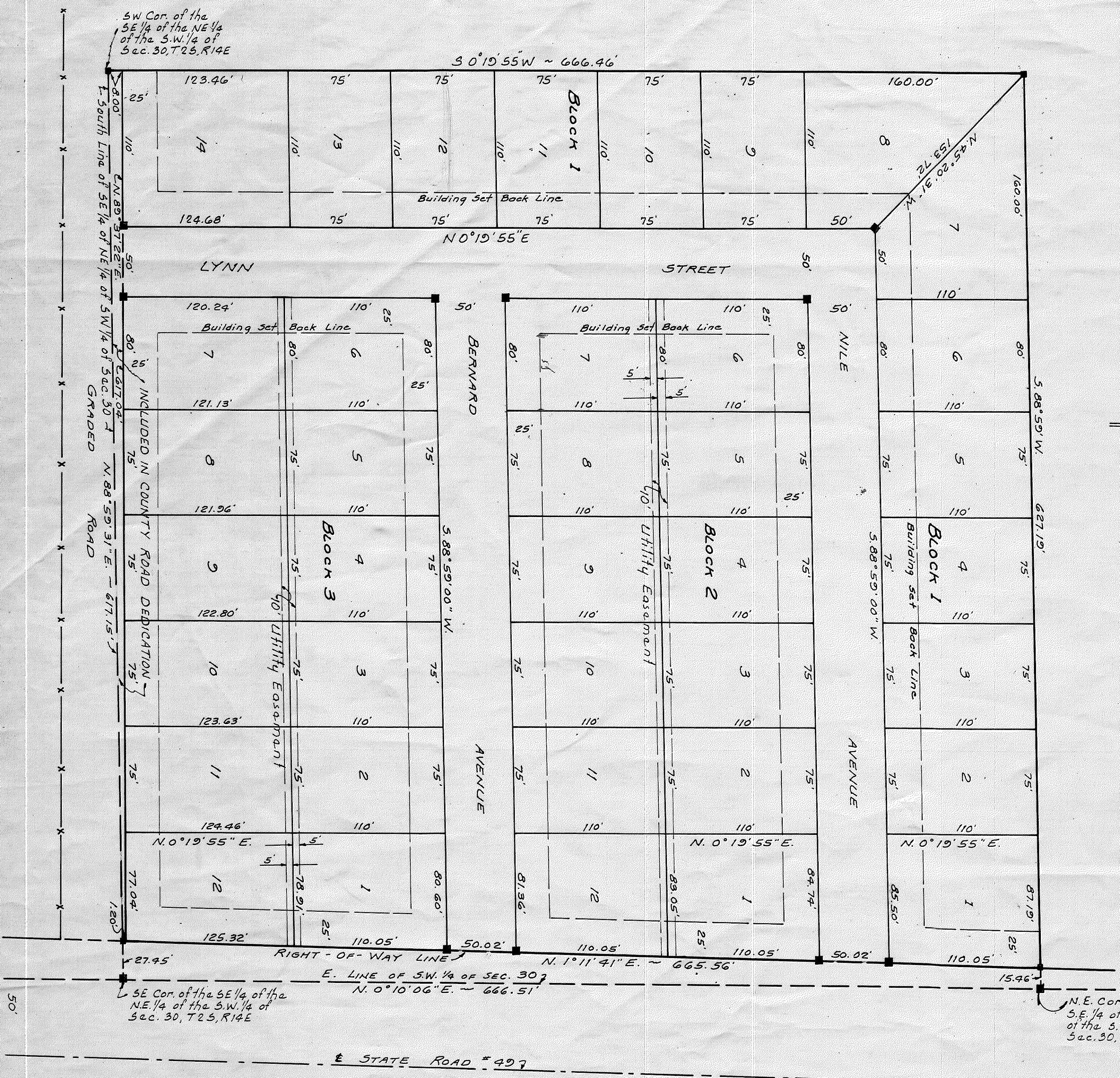
BRANDON ESTATES
