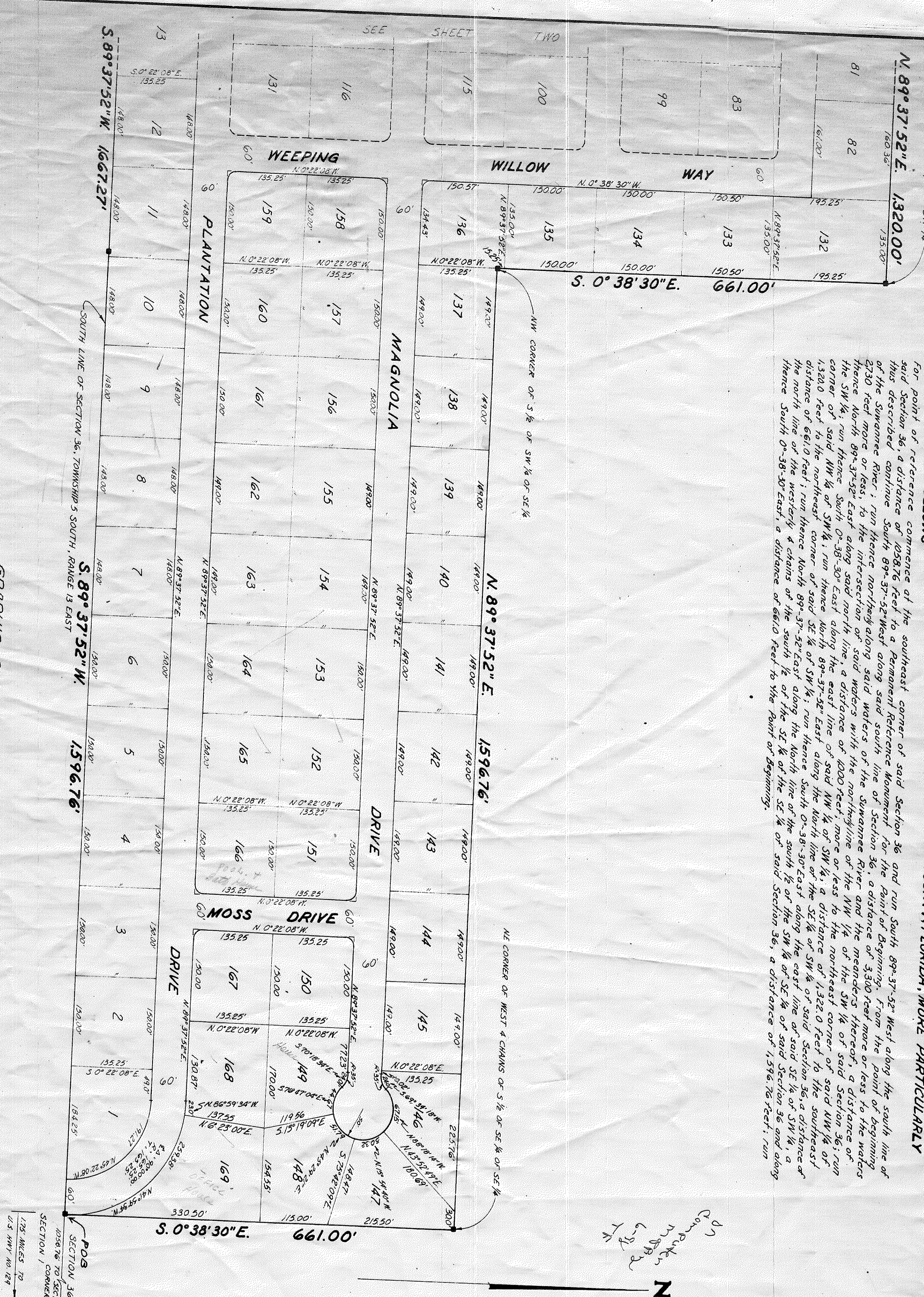

CAPTION:
THE FRACTIONAL WEST HALF OF THE SOUTHWEST QUARTER; THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER; THE SOUTH HALF OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER; AND THE WEST FOUR CHAINS OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER; IN SECTION 36, TOWNSHIP 5 SOUTH, RANGE 13 EAST, SUWANNEE COUNTY, FLORIDA, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

For point of reference commence at the southeast corner of said Section 36 and run South 89° 37' 52" West along the south line of said Section 36, a distance of 1330.00 feet to a Permanent Reference Monument for the Point of Beginning, from the point of beginning this described continue South 89° 37' 52" West along said south line of Section 36, a distance of 3,300 feet more or less to the water of the Suwannee River; run thence northwesterly said water's edge of the Suwannee River and the meanders thereof, a distance of 2,300 feet more or less; thence North 89° 37' 52" East along said north line, a distance of 1,000 feet; more or less to the northeast corner of said NW 1/4 of said Section 36; run thence North 89° 37' 52" East along the east line of said NW 1/4, a distance of 1,322.0 feet to the northeast corner of said NW 1/4 of said Section 36; run thence South 0° 38' 30" West along the south line of the SE 1/4 of said Section 36, a distance of 661.00 feet to the northwest corner of said SE 1/4 of said Section 36; run thence South 0° 38' 30" East along the east line of the SE 1/4 of said Section 36, a distance of 1,596.76 feet; run thence North 89° 37' 52" East along the north line of the SE 1/4 of said Section 36, a distance of 1,596.76 feet; run thence South 0° 38' 30" East, a distance of 661.00 feet to the Point of Beginning.
