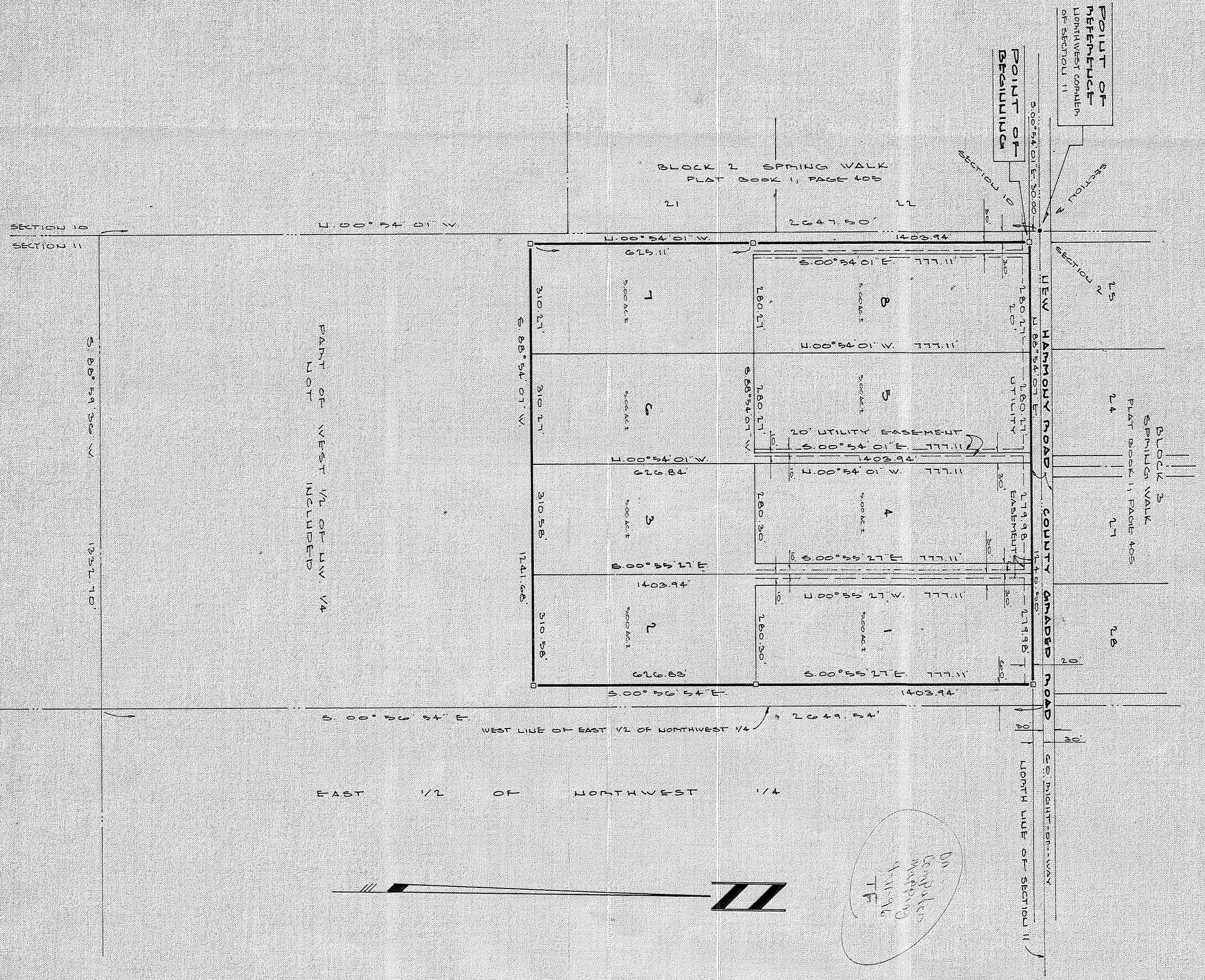

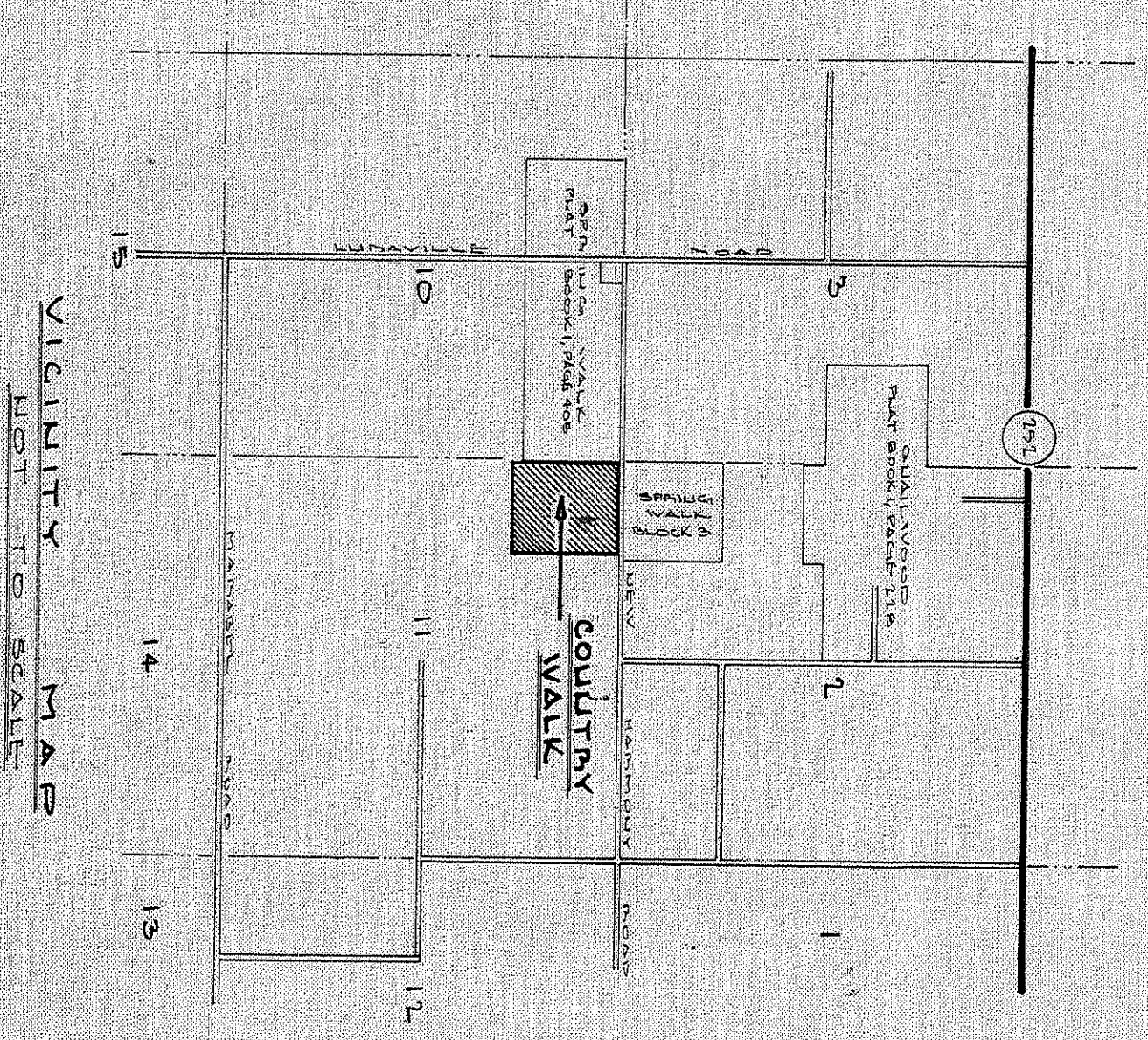
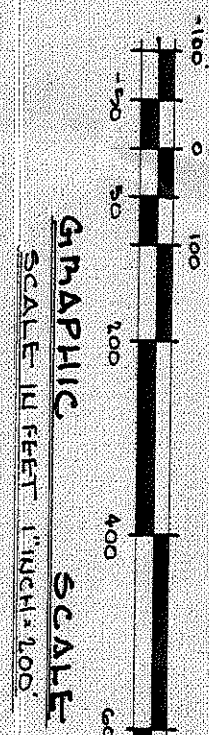
# COUNTY WALK
