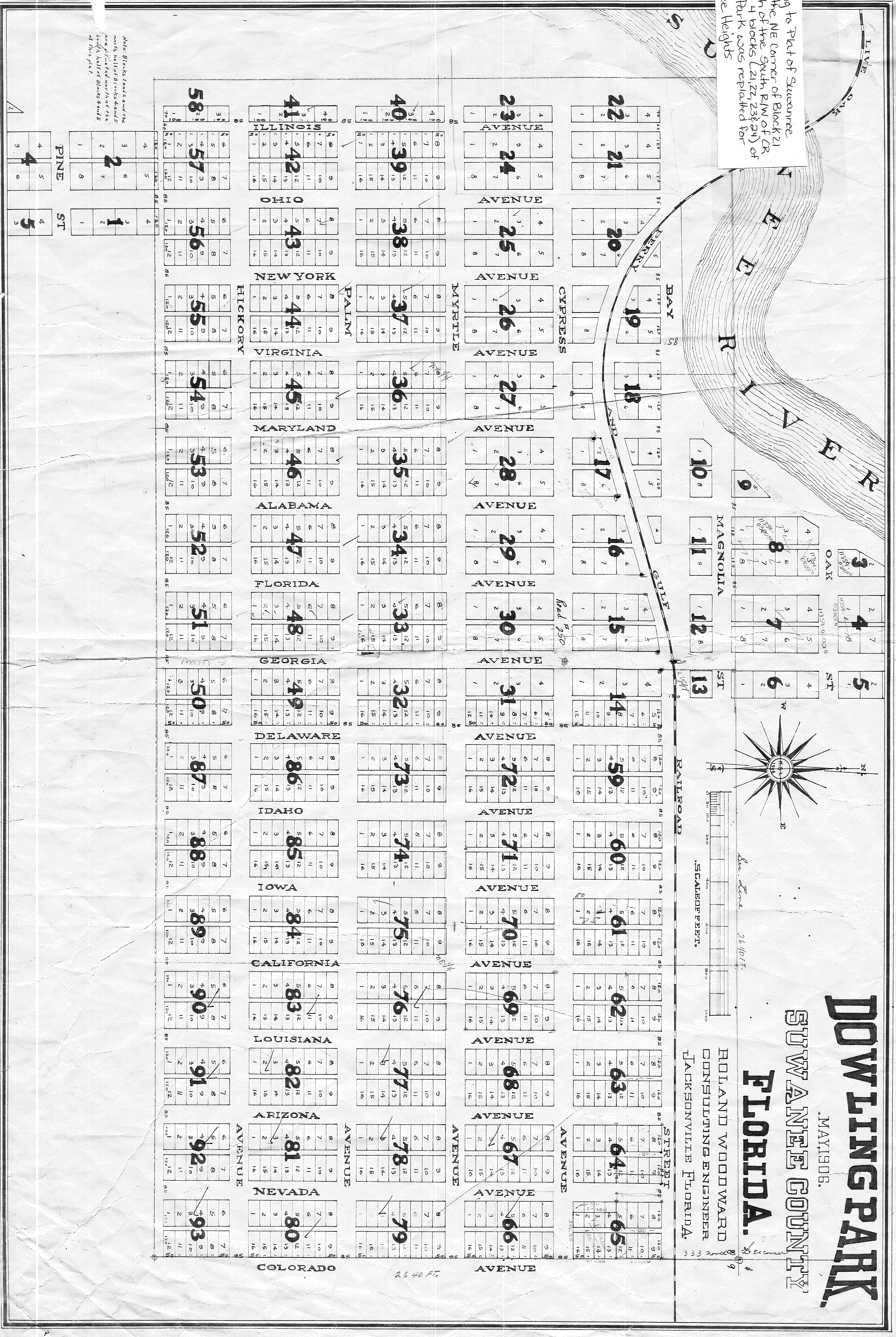
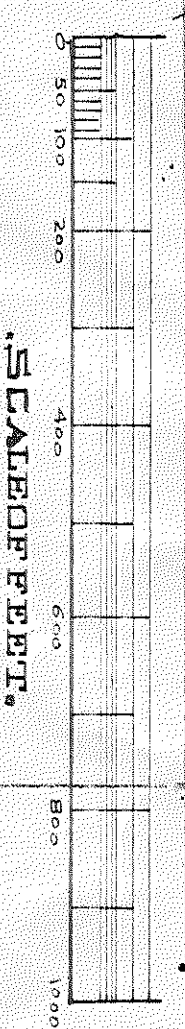
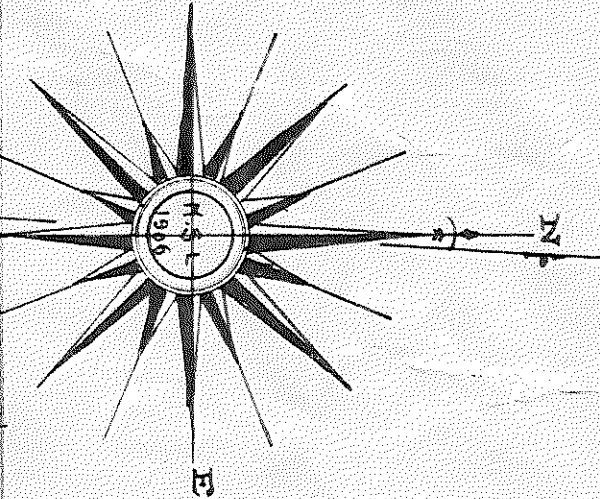

PLAT OF SUWANNEE HEIGHTS

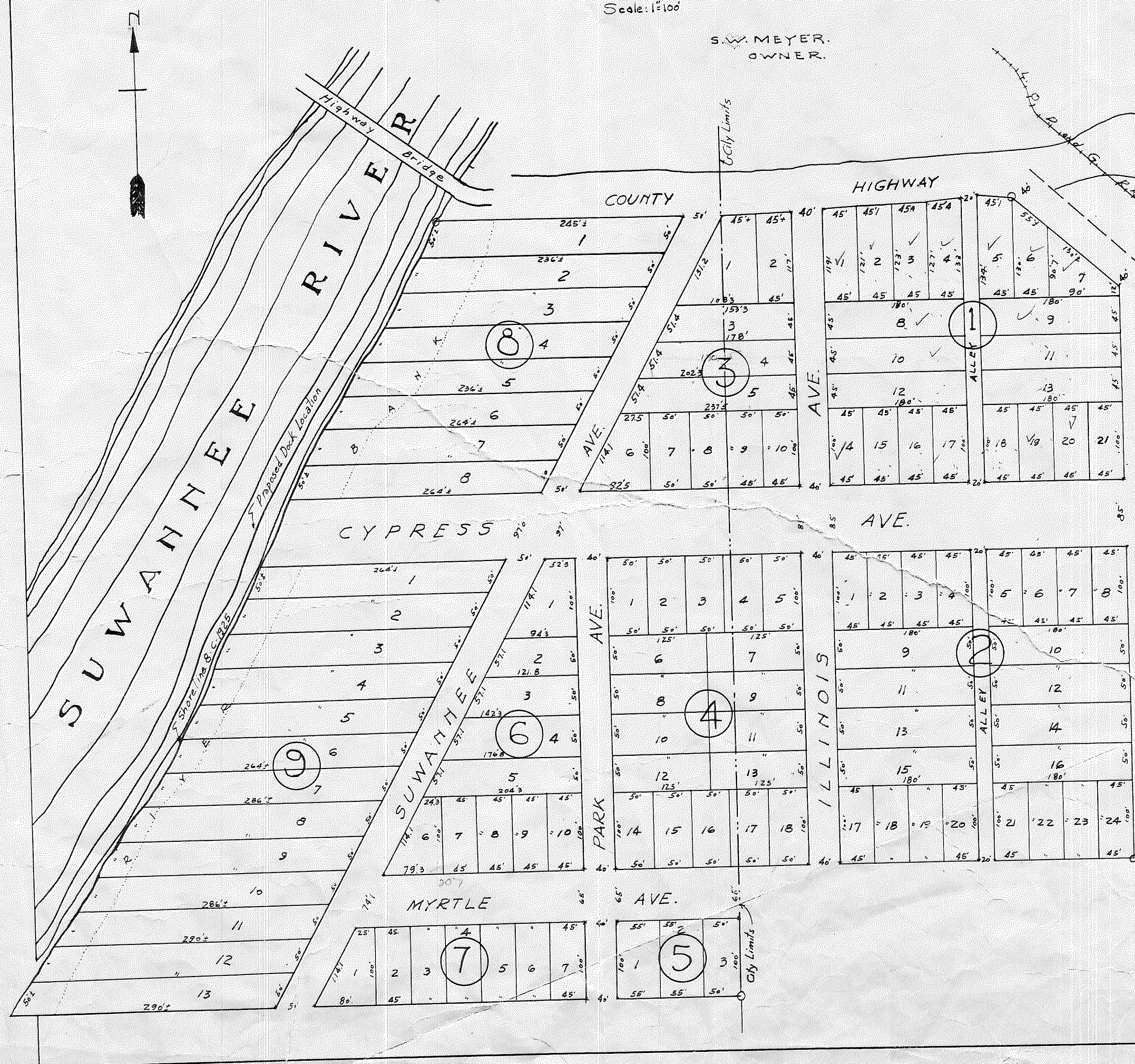

Description of Property: - Intra Blks. 21, 22, 23 and 24 in the recorded town plat of Dowling Park and a certain parcel of land beginning at a point on the section line between Sections 7 and 8 township 3 South, Range 11 East, 126 feet South from the Southeast corner of the Northeast one-quarter of the North-east one-quarter of Section 7, Twp. 3 S., R. 11 E. thence North along the section line between Sections 7 and 8, 350' R. 11 E. to the County road in a Westerly direction to the bank of the Suwannee River, thence in a Southwesterly direction along the East bank of the Suwannee River to a point on the East bank of the Suwannee River directly West from the point of beginning, and thence Eastward to the point of beginning containing twelve and one-half acres, more or less.
