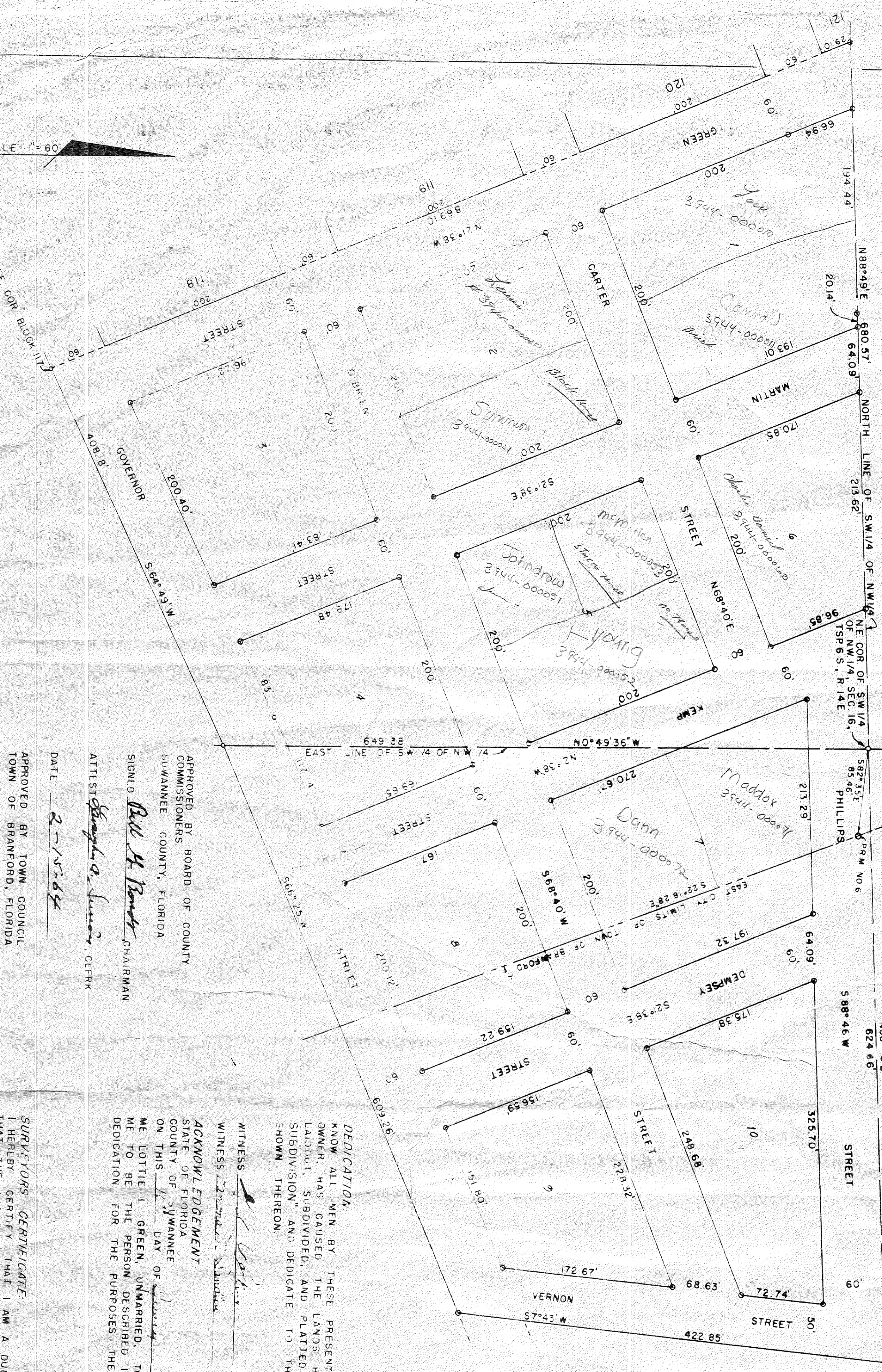


GREEN ACRES SUBDIVISION

A SUBDIVISION OF A PART OF THE S 1/2 OF THE NW 1/4 OF SEC. 15, T. 6 S., R. 14 E., BEING A PART OF THE TOWN OF BRANFORD AND OTHER LANDS, IN SUWANNEE COUNTY, FLORIDA



DESCRIPTION
 BEGIN AT THE NORTHEAST CORNER OF SW 1/4 OF NW 1/4, SECTION 14, TOWNSHIP 6 SOUTH, RANGE 14 EAST, AND RUN THENCE N88°46'E, ALONG THE NORTH LINE OF THE S 1/2 OF SAID NW 1/4, 624.66', THENCE RUN S7°43'W, 422.85', THENCE RUN S66°25'W, 609.26', THENCE RUN S64°49'W, 408.8' TO THE NE CORNER OF BLOCK 117, TOWN OF BRANFORD, THENCE RUN N21°58'W, 212.0', THE EAST LINE OF BLOCKS 118, 119, 120, AND 121, TOWN OF BRANFORD, 869.10' TO THE NORTH LINE OF SAID SW 1/4 OF NW 1/4, THENCE RUN N88°49'E ALONG SAID NORTH LINE OF SW 1/4 OF NW 1/4, 680.57' TO THE POINT OF BEGINNING SAID LANDS LYING IN THE S 1/2 OF NW 1/4 OF SECTION 16, TOWNSHIP 6 SOUTH, RANGE 14 EAST AND CONTAINING 1737 ACRES MORE OR LESS
