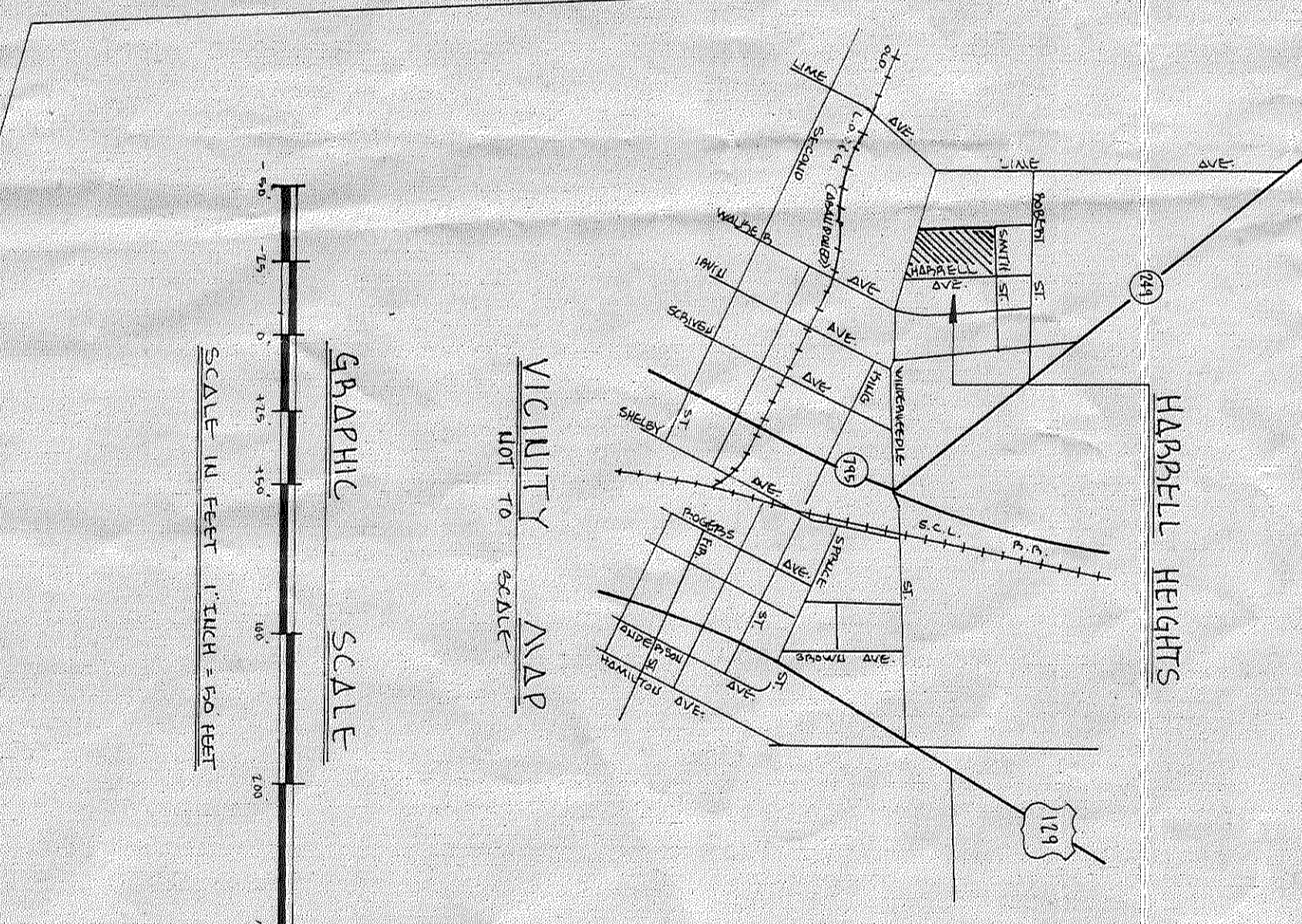
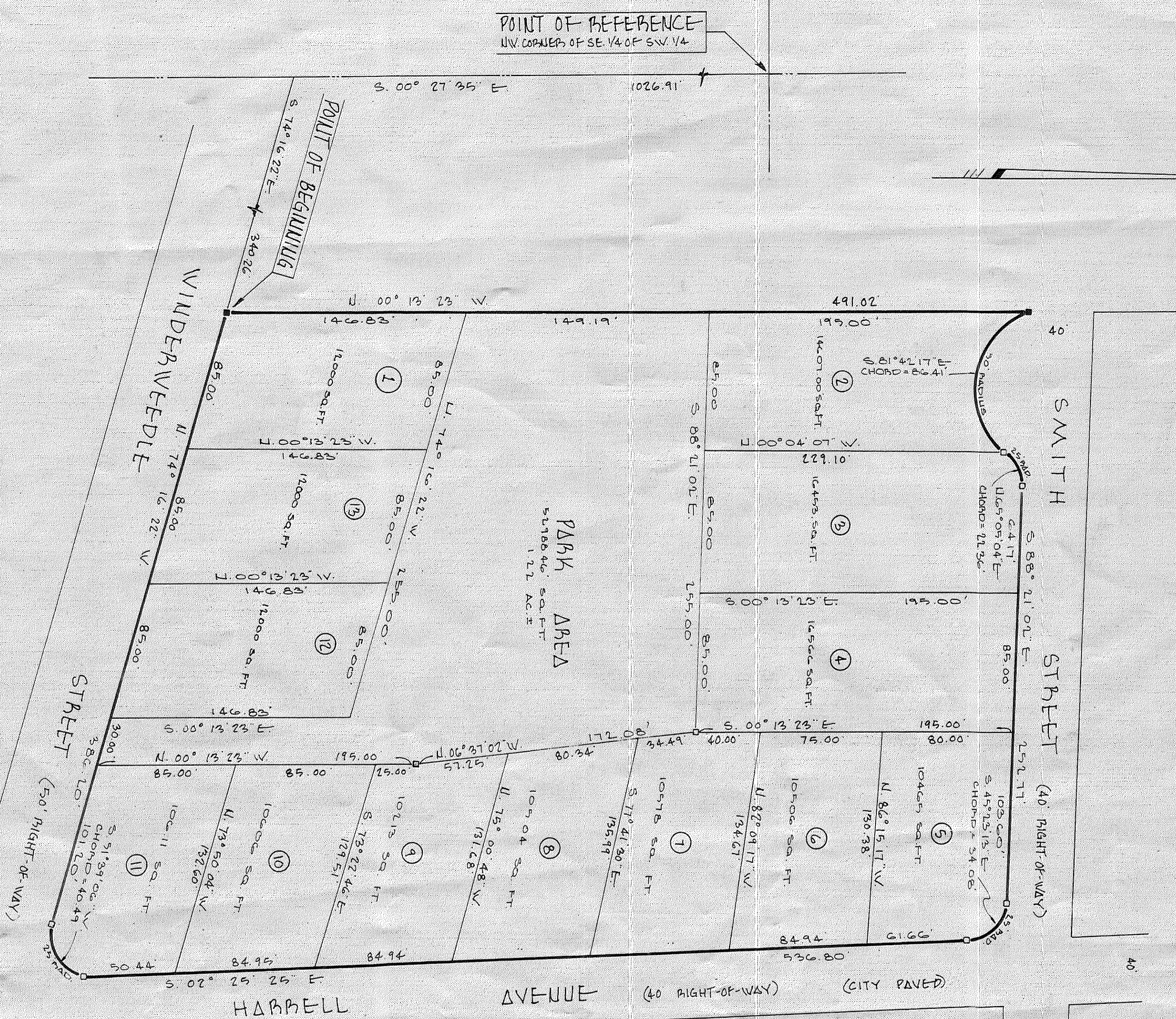


HARRRELL HEIGHTS

SITUATED IN:

PART OF THE SOUTHEAST 1/4 OF SECTION 11, TOWNSHIP 2 SOUTH, RANGE 13 EAST, SUWANNEE COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: FOR POINT OF REFERENCE COMMENCE AT THE NORTHWEST CORNER OF THE SOUTHWEST 1/4 OF THE SOUTHEAST 1/4, THENCE RUN SOUTH 02° 22' 22" EAST, A DISTANCE OF 440 FEET TO THE POINT OF BEGINNING; THENCE RUN NORTH 82° 57' 55" WEST, A DISTANCE OF 150 FEET TO THE SOUTH RIGHT-OF-WAY LINE OF SMITH STREET, THENCE RUN SOUTH 82° 02' 02" EAST ALONG SAID SOUTH RIGHT-OF-WAY LINE A DISTANCE OF 381.88 FEET TO THE WEST RIGHT-OF-WAY LINE OF HARRRELL AVENUE, THENCE RUN SOUTH 02° 25' 25" EAST ALONG SAID WEST RIGHT-OF-WAY LINE A DISTANCE OF 594.59 FEET TO THE NORTH RIGHT-OF-WAY LINE OF WINDREWEEDLE STREET, THENCE RUN NORTH 74° 16' 22" WEST ALONG SAID NORTH RIGHT-OF-WAY LINE A DISTANCE OF 420.70 FEET TO THE POINT OF BEGINNING.
