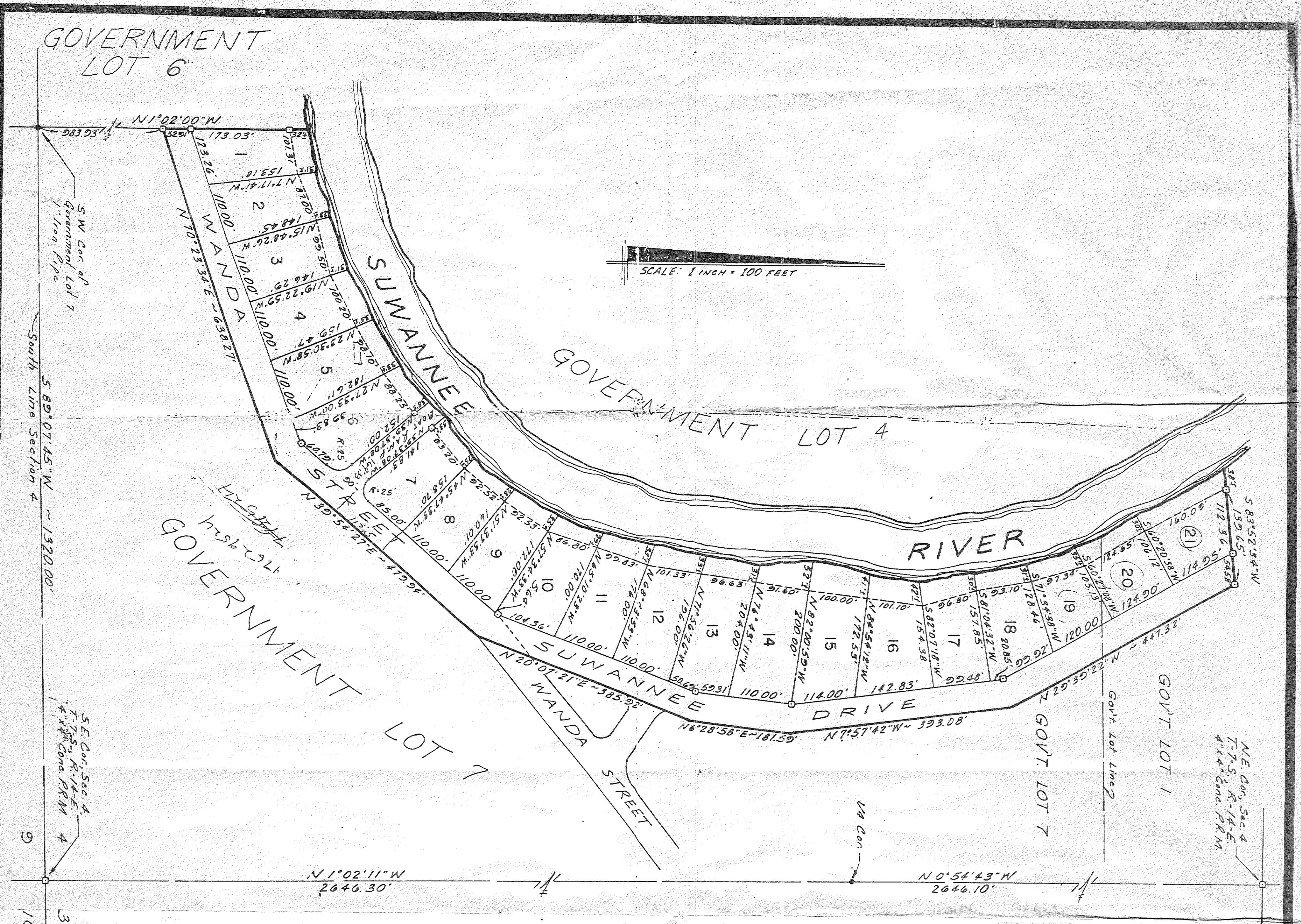


Little Horseshoe Unrecorded

THE LITTLE HORSESHOE

BEING A PART OF GOVT. LOTS 1 & 7,
SECTION 4, TOWNSHIP 7 SOUTH, RANGE 14 EAST
SUWANNEE COUNTY, FLORIDA



DESCRIPTION:
 COMMENCEMENT of the Southeast Corner of Section 4, Township 7 South, Range 14 East, Suwannee County, Florida and run S 89° 07' 45" W along the South Line of said Section 4 a distance of 1320.00 feet to a 1 inch iron pipe on the SW Corner of Government Lot 7, thence N 1° 02' 00" W along the West line of said Government Lot 7 a distance of 953.93 feet to the POINT OF BEGINNING; thence N 70° 43' 14" E 638.27 feet; thence N 29° 58' 27" E 479.94 feet; thence N 20° 10' 21" E 385.22 feet; thence N 6° 28' 58" E 14.59 feet; thence N 7° 57' 42" W 393.08 feet; thence N 29° 30' 22" W 447.32 feet; thence S 83° 52' 59" W 132.45 feet to a 1 inch iron pipe on the East bank of the Suwannee River; thence continue S 83° 52' 59" W along same line 38 feet more or less to the Waters Edge of the Suwannee River; thence Southwesterly and Westerly along and with the meander of the waters edge of the Suwannee River 2100 feet more or less to a point on the West line of Government Lot 7, said point being N 1° 02' 00" W 258 feet more or less from the POINT OF BEGINNING; thence S 1° 02' 00" E 32 feet more or less along said West line of Government Lot 7 to a 1 inch iron pipe on the Southern bank of the Suwannee River; thence continue S 1° 02' 00" E along same line 225.94 feet to the POINT OF BEGINNING.
