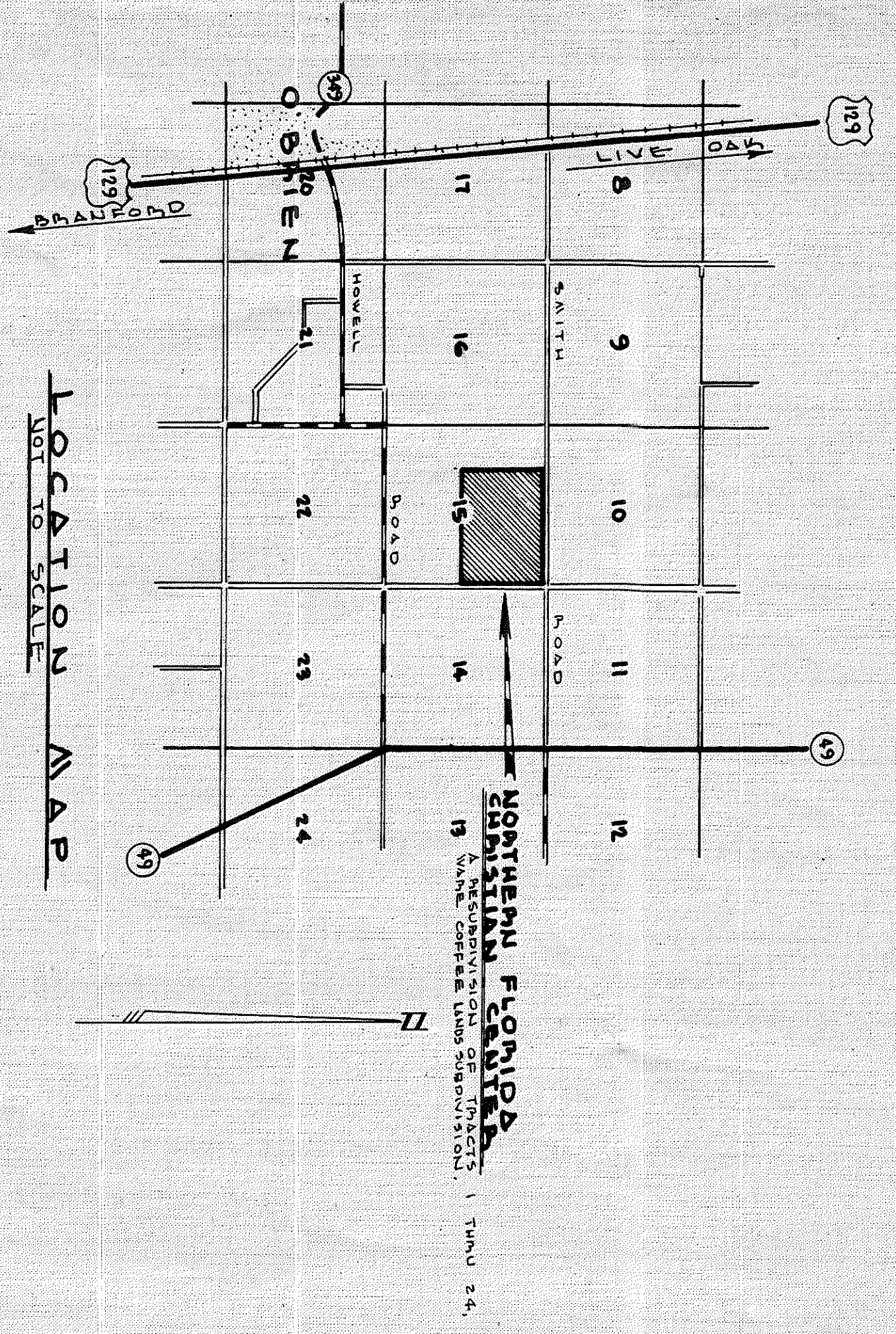

LOCATION MAP

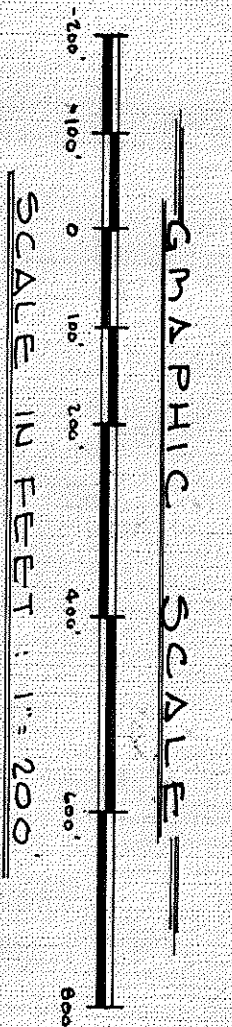
