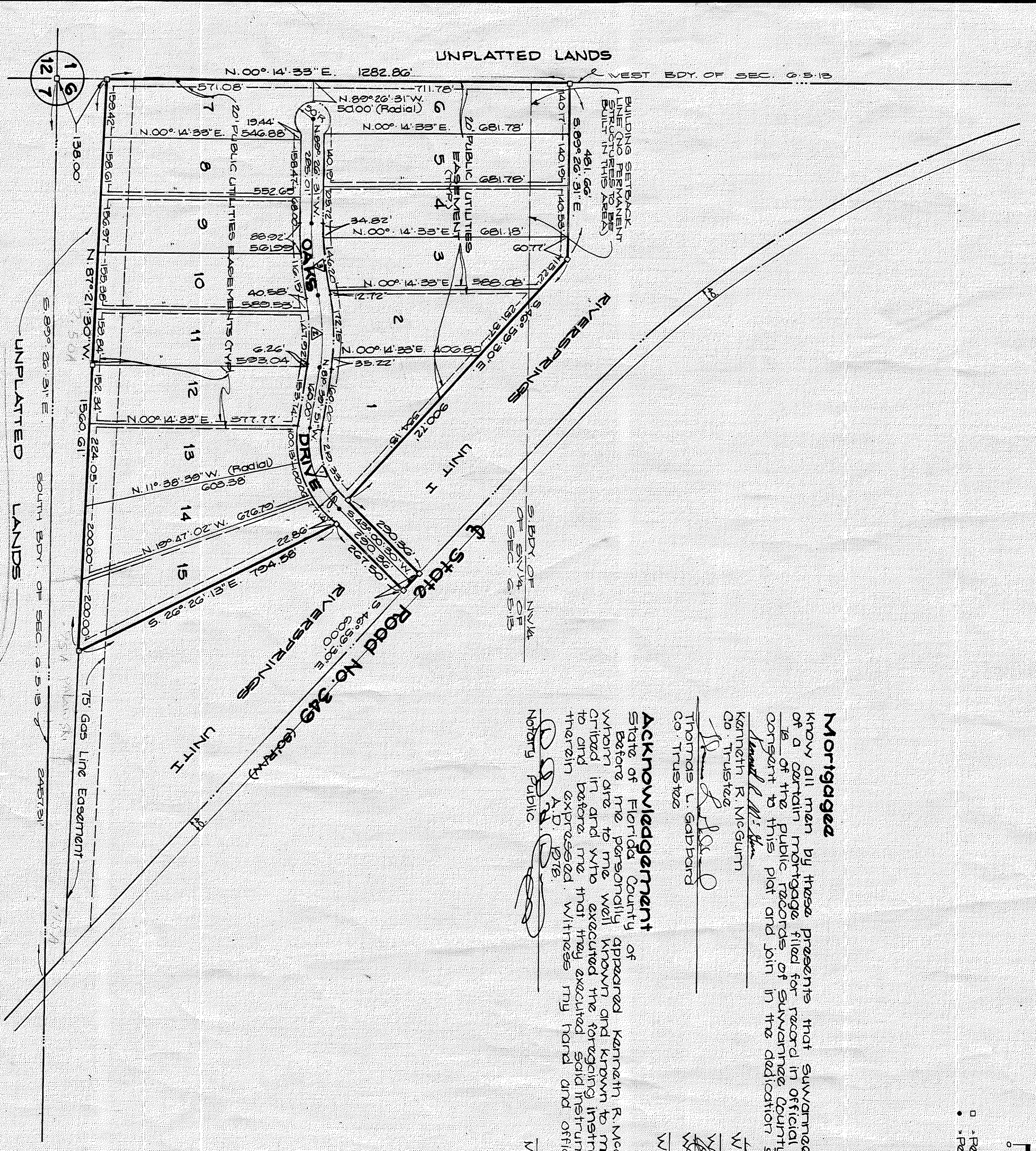
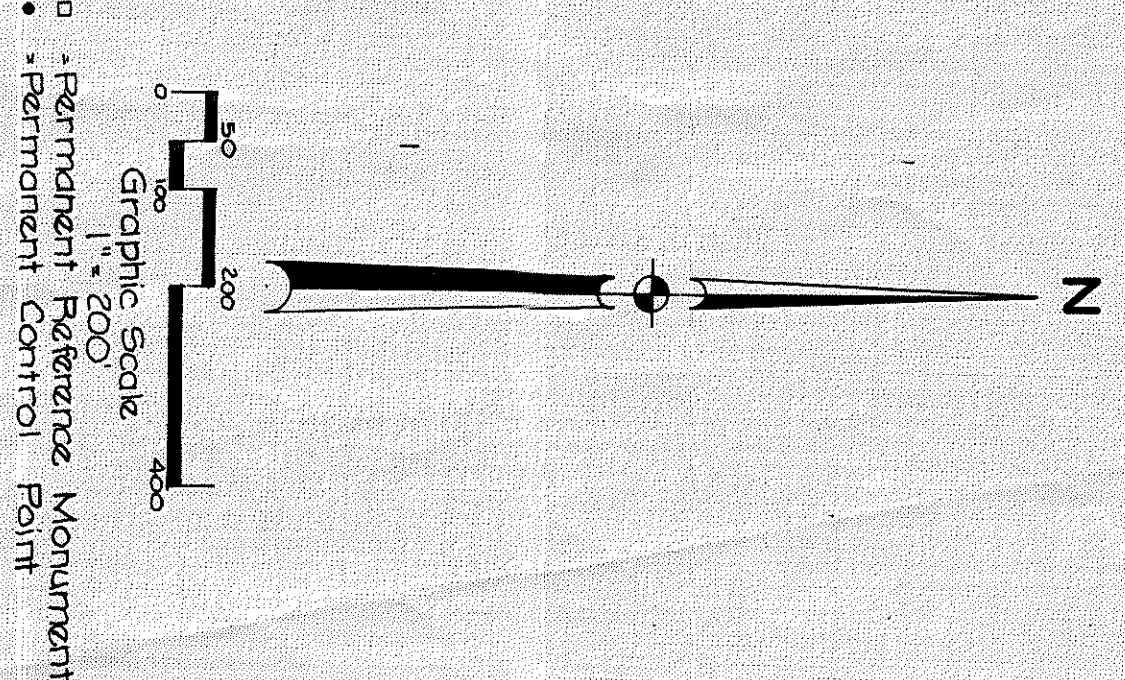
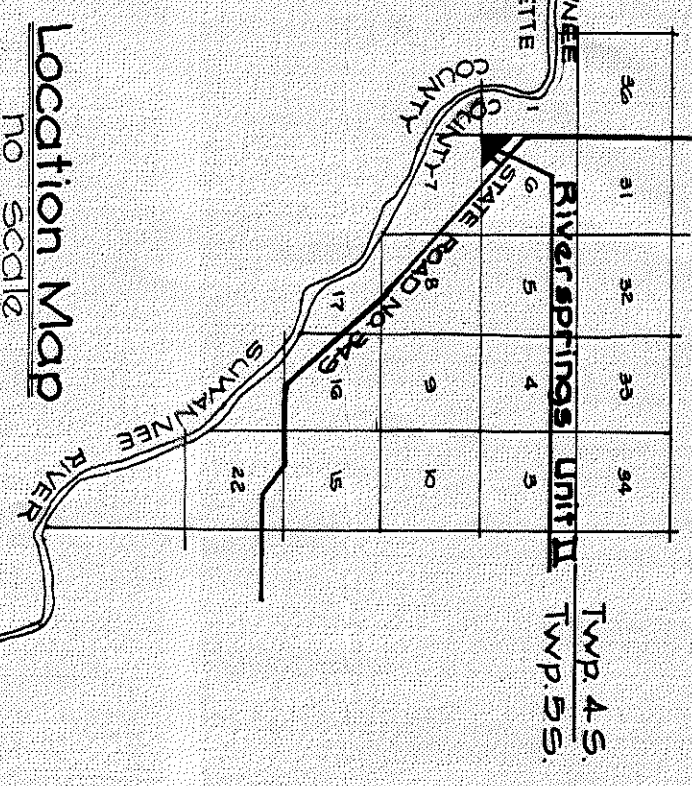


RIVERSPRINGS UNIT II
