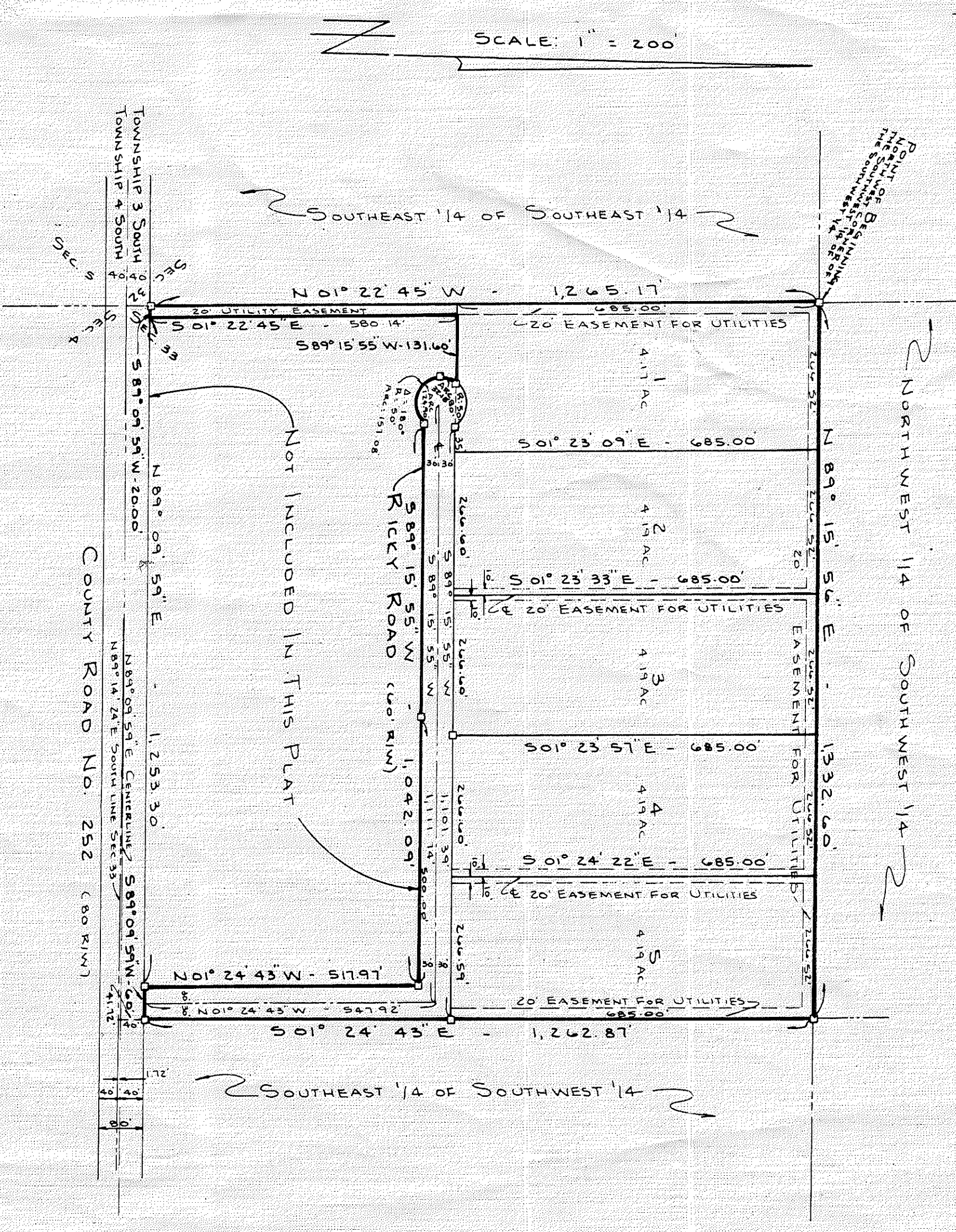
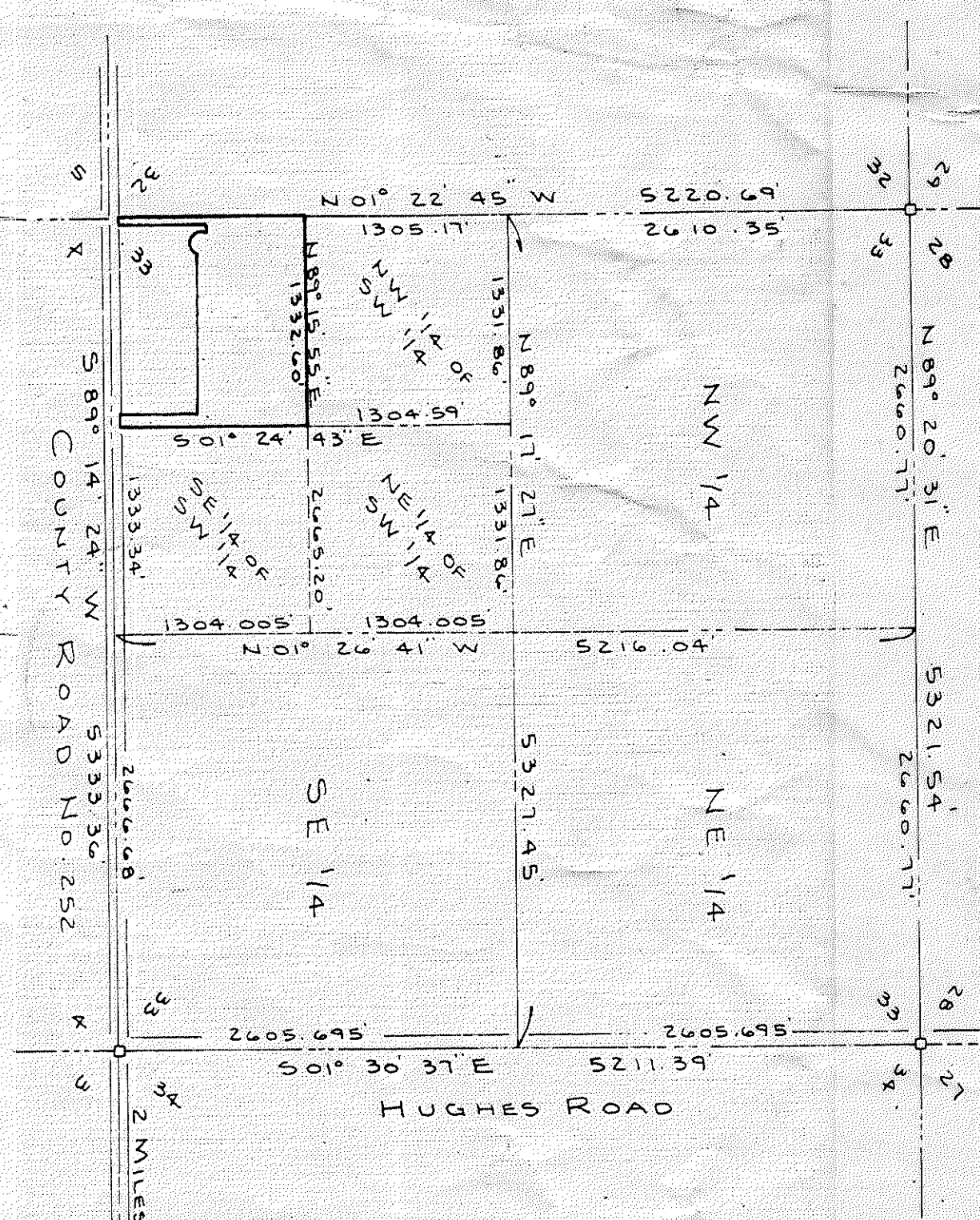
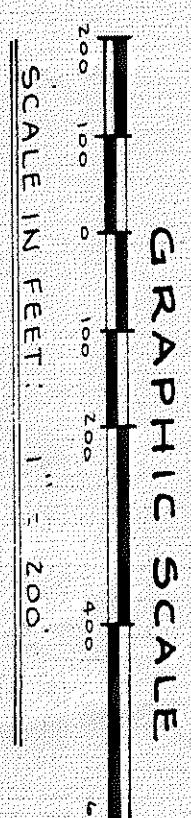


SOULES RANCHETTES

DESCRIPTION:
