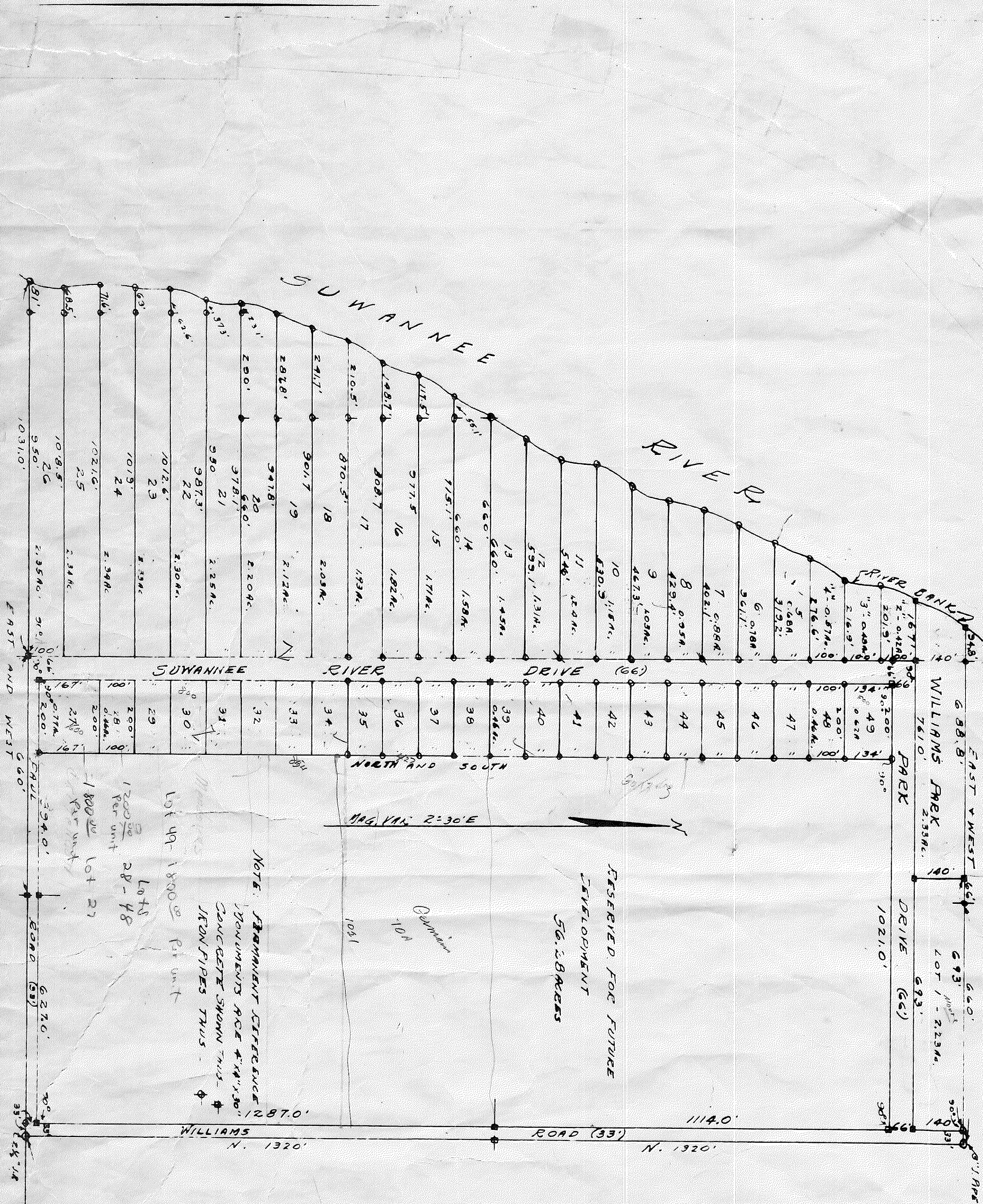


SUNANNEE RIVER TERRACE
