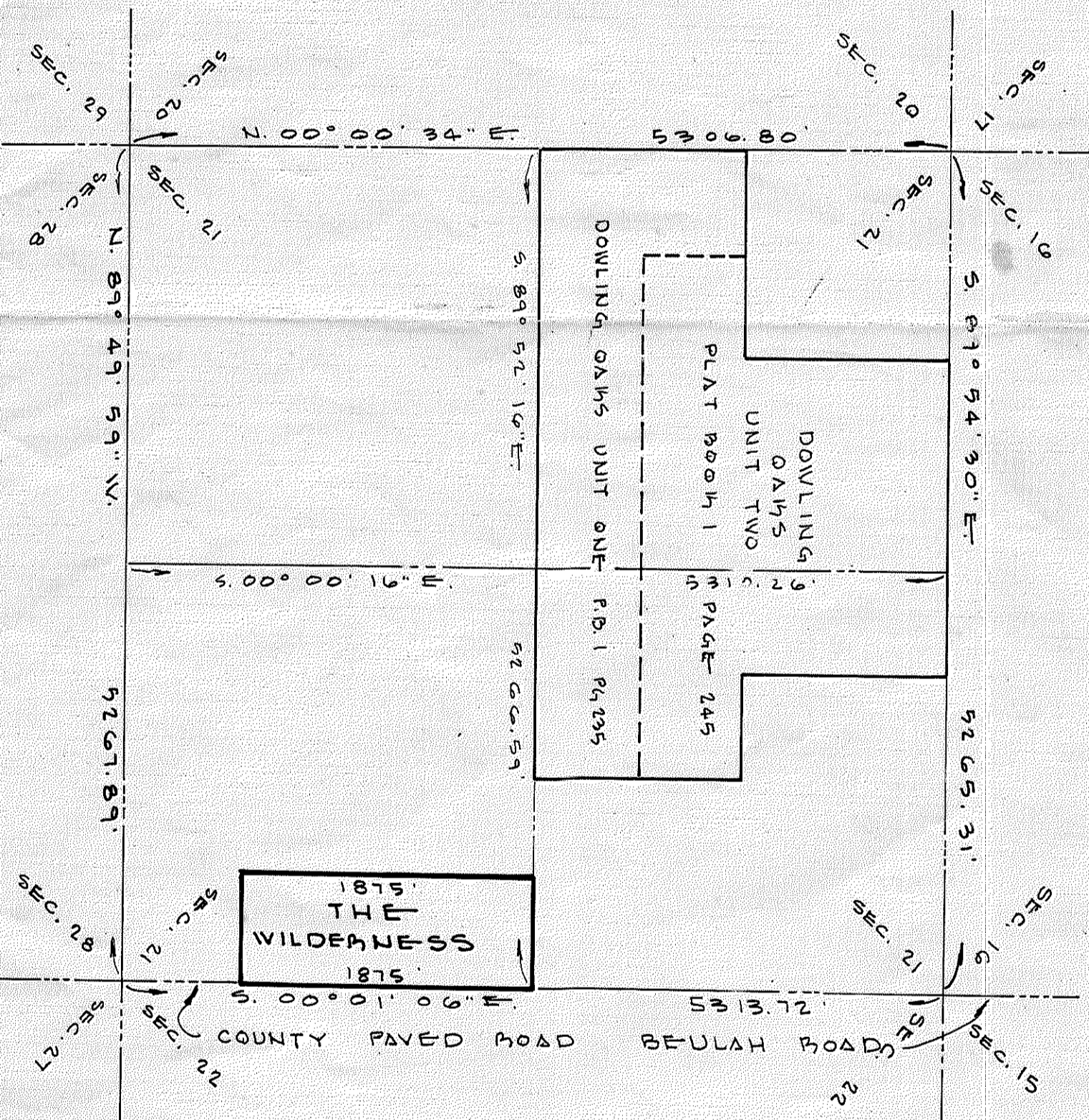
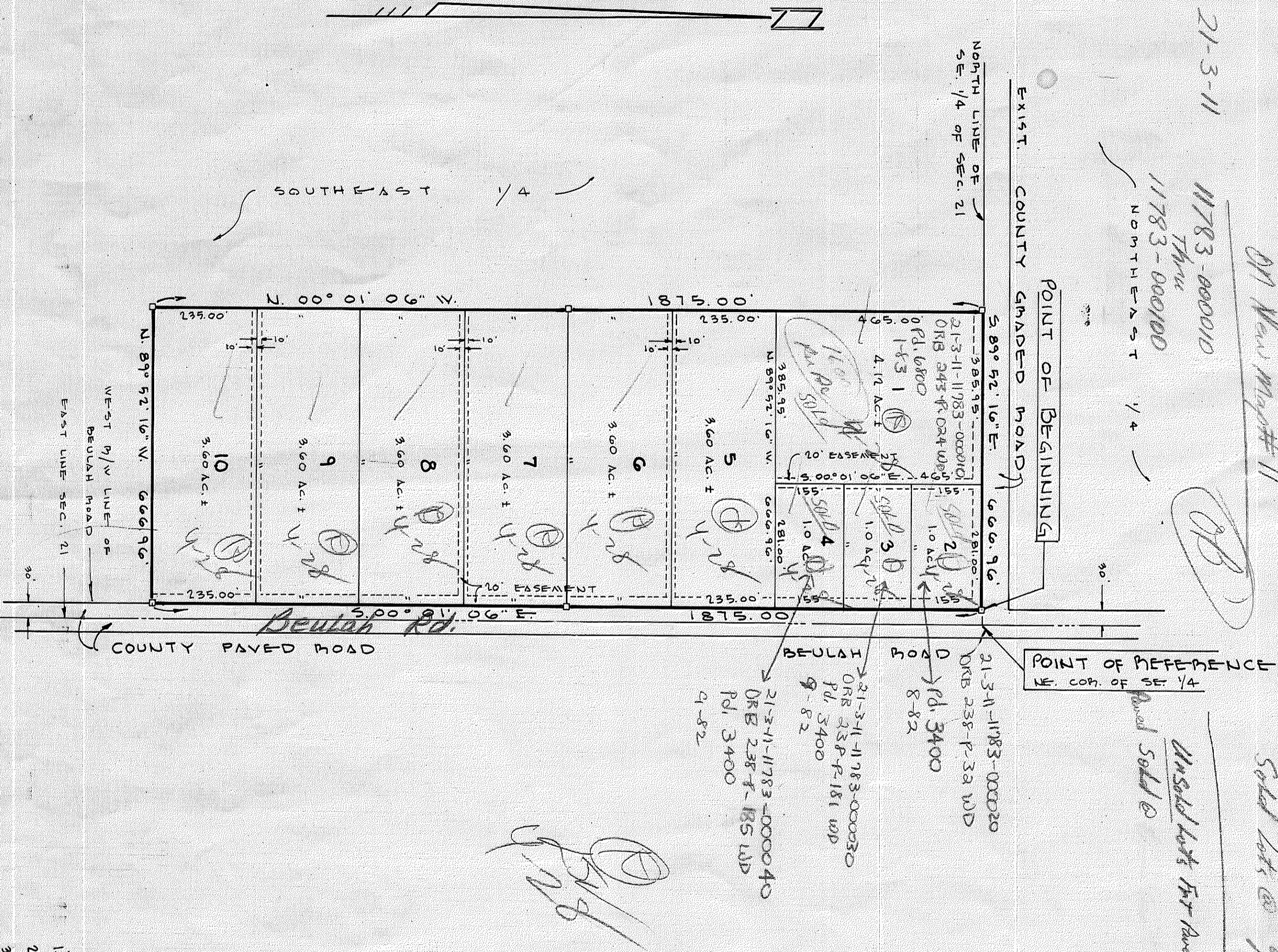
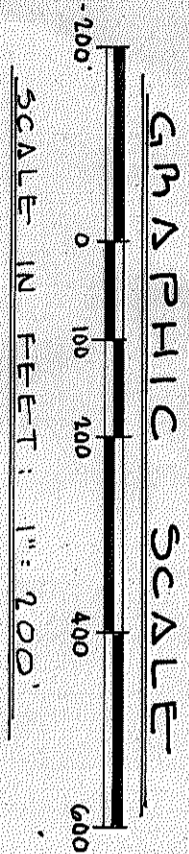


# THE WILDERNESSES

SITUATED IN SOUTH RANGE 21 EAST, SUWANNEE COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: FROM POINT OF REFERENCE COMMENCE AT THE NORTH-EAST CORNER OF SAID SOUTH-EAST 1/4, THE DISTANCE 89° 52' 16" WEST ALONG THE NORTH LINE OF SAID SOUTH-EAST 1/4, A DISTANCE OF 300.00 FEET TO THE WEST ALONG THE WAY LINE OF SAID SOUTH-EAST 1/4, THE POINT OF BEGINNING; THENCE RUN SOUTH 00° 01' 06" EAST ALONG SAID WEST RIGHT-OF-WAY LINE, A DISTANCE OF 1,875.00 FEET; THENCE RUN NORTH 89° 52' 16" WEST, A DISTANCE OF 666.96 FEET; THENCE RUN SOUTH 89° 52' 16" EAST ALONG SAID NORTH LINE OF THE SOUTH-EAST 1/4, A DISTANCE OF 666.96 FEET TO THE POINT OF BEGINNING.
