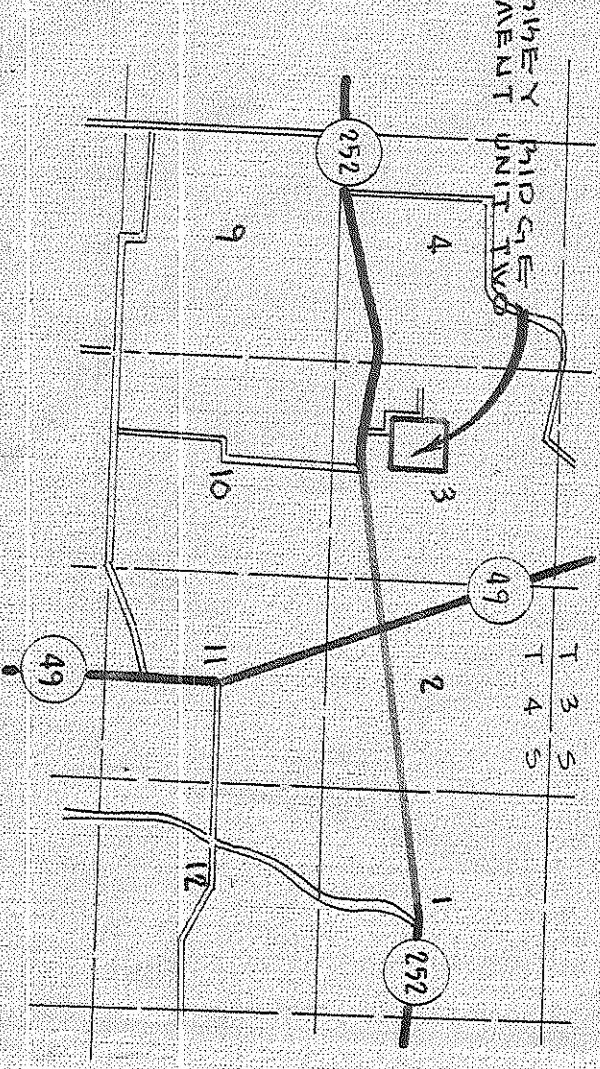
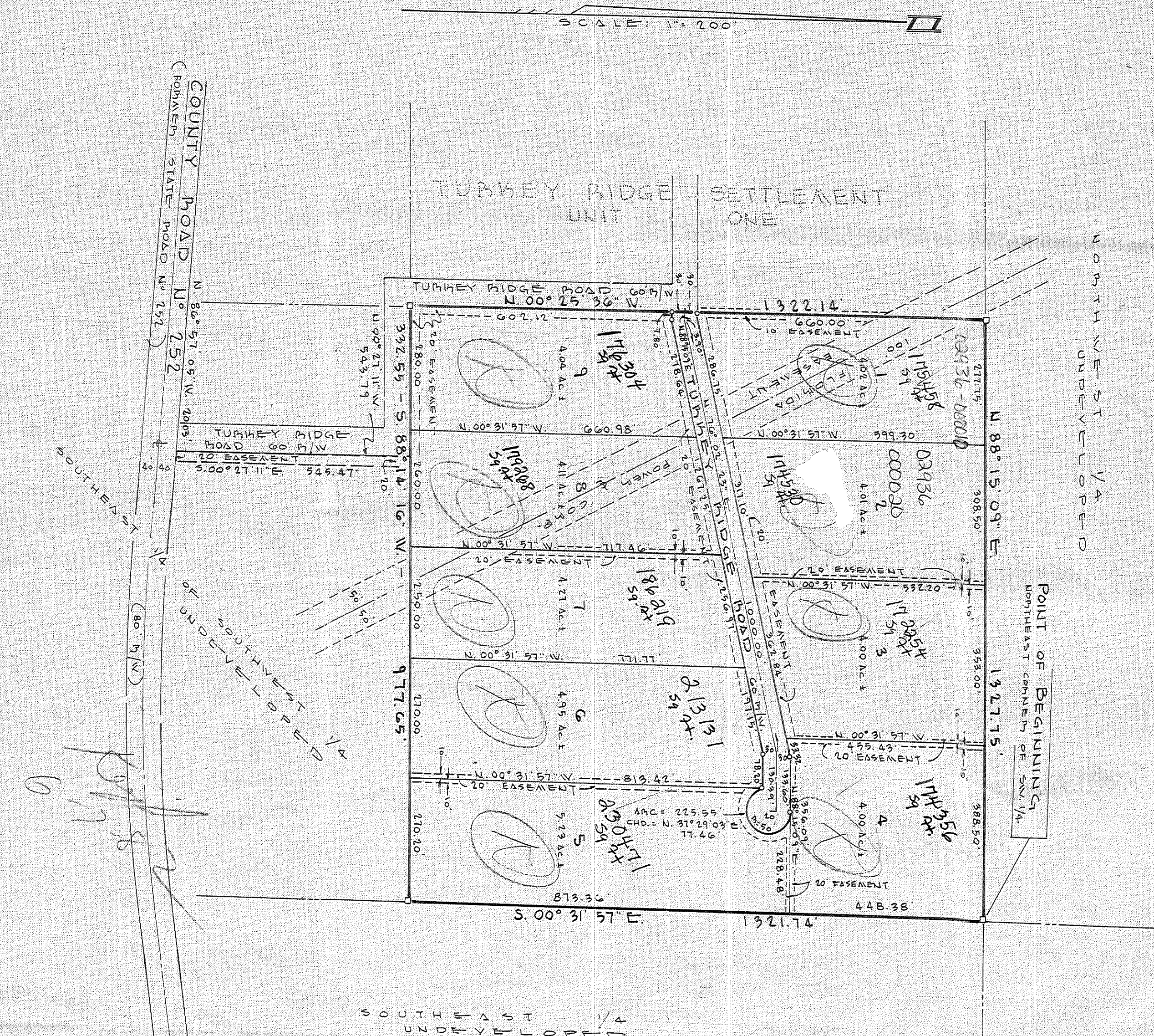
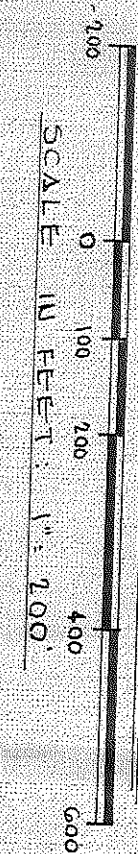


TURKEY RIDGE SETTLEMENT UNIT TWO
